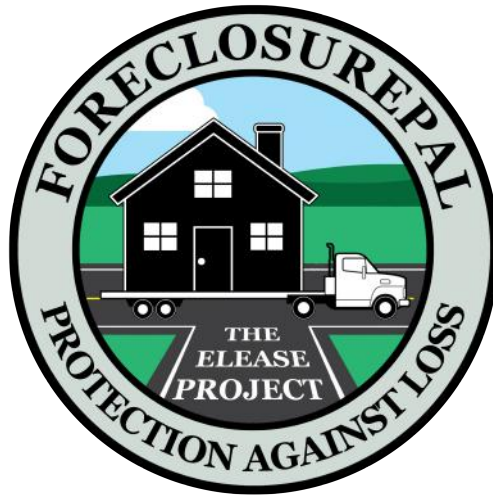

Section 1

Introduction to ForeclosurePAL

ForeclosurePAL is one of the 10 important pieces of The Elease Project. It is comprised of two parts. (Part one) Part one of ForeclosurePAL is to save families and individuals homes from being foreclosed on. When a family goes into foreclosure, there are actually two foreclosures. The family is put on the street and the home goes into shambles. Both the family and the home are damaged. ForeclosurePAL provides dollars to get people that are behind on their mortgages totally caught up and out of foreclosure. Keith and his team have already saved one family's home in Tennessee. The husband lost his job and Insurance license. They got nine months behind on the mortgage for the first time in 23 years. They came within four hours of losing their home to a bank that was going to auction off their home out on the courthouse steps. Keith and his team came up with \$25,000 to catch up the payments. Next he worked with the family to list their bills smallest to largest to get out of debt. The monthly bills have already been reduced by at least \$1000 per month. The utility bills were reduced. The homeowners insurance was

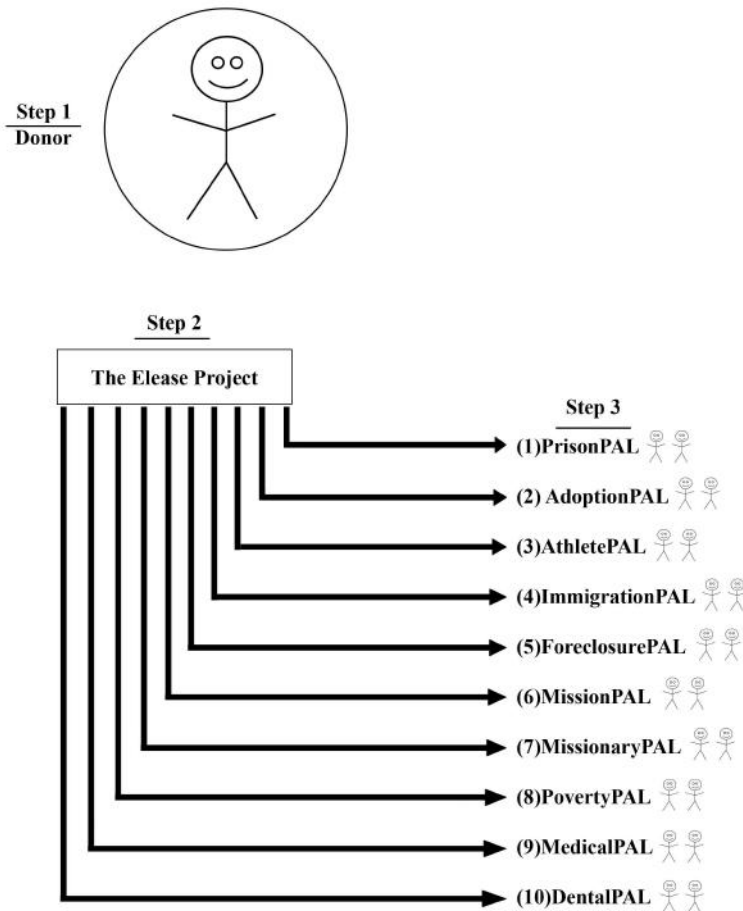
reduced. The auto insurance was reduced. The cell phone bills were reduced. Their home had around \$250,000 equity on it. Now we are refinancing their home to get their credit cards paid in full. They have a signature title loan of \$444 per month that will be paid off. All the people that loaned them money will be paid back. Their payment is actually almost the same as it is now. The family needed help. No one including their own church would give them money. We are thankful for the opportunity to honor God through this program. The Elase Project is about honoring God. Elase Hatchett always gave people a chance when they had no chance. Keith knows his mother, had she been alive this year, would be so proud of these actions of help. The family is well on their way to recovery. Soon all their self inflicted bills will be paid and they will be on their way to success and living a great peaceful life financially. (Part two) Keith created ForeclosurePAL also to fight banks that are wrongfully stealing innocent peoples homes. These banks are committing fraud with false titles, excepting wrongful buyout checks from the government, paying off crooked judges, and flat out stealing peoples homes without authority or ownership of the home. 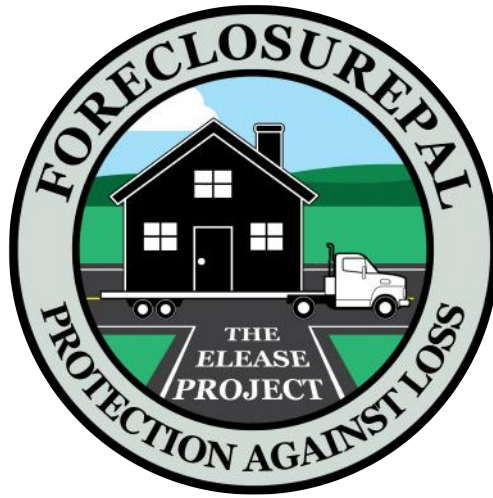
The Ten PALS Structure

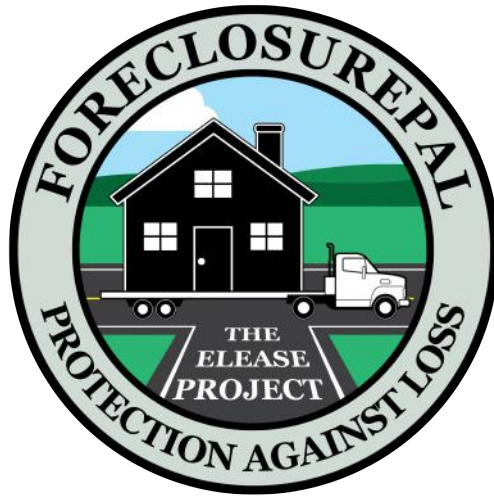

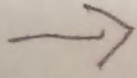
