Section 1

Introduction to ImmigrationPAL

ImmigrationPAL is one of the 10 important pieces of The Elease Project. It is comprised of three parts. (Part one) Many families have been separated by old, outdated, and antiquated immigration policies. Most of the immigration laws created around 1996 are nothing more than racism and hate. These laws were created by racist politicians in Texas. ImmigrationPAL's goal in part one is to work hard to get these laws changed. It is very important to have immigration laws and rules. There must be a process of coming here legally from other countries. The current immigration process is simply just too long. Many of the immigration rules violations destroy lives with harsh punishments of ten year bars of entry back into the United States. In some cases such as false claim to citizenship, the immigration death penalty is applied and the immigrant is permanently barred forever from re-entry into the United States. This permanent bar must be taken off the books and reversed immediately. The government makes a lot of money off of the bonds when they put people in private prisons such as Corrections Corporation of

America. It is not even a criminal offense to come here. It is a **civil offense** to come here unlawfully to the United States. All these immigrants want is to be with their families and to have a chance to escape poverty through the benefits that this great country offers. All of us come here through our ancestors in one way or another through immigration. Keith has worked hard over the last 10 years to rewrite the immigration laws. He also has rewritten the civil punishment codes to be more fair. He has created revenue streams for the government that will replace the billions of dollars every month that the government is generating by destroying families and individuals lives and throwing them in the immigration prison. Some very bad people figured out how to take immigration laws that protect our country and illegally make billions of dollars off of the bonds and they started raiding homes, picking up people, and throwing them in jail for money. After they got paid, they take a portion of these dollars and fly the immigrant into deportation land which is the original country that they are from. They kick him/her off of the airplane and could care less if they die or not. This must be corrected and stopped. ImmigrationPAL will work hard to change these corrupt actions immediately. (Part two) ImmigrationPAL will be the agent for thousands of immigrants families. We will keep the families of the victims from being prayed upon by unscrupulous attorneys, corrupt judges, and companies that scam immigrants out of their money. We will set up a network of approved law firms that are good. We will create intake forms to get the information on each case. We will inform each family of the process and the order of the process. They will be given a list of forms and what each form means and the order of the forms and the documents so that there are not delays in the case. The costs and the expected timelines are laid out for the immigrant and the immigrant's family. This

process will ease the burden of the unknown. Each individual will pay \$59 per month and families will pay \$89 per month to be members of ImmigrationPAL. As a member they will receive discounted attorney rights and expedited timelines on their cases. A website is created on the story and it's progress. Churches and families can log on and help sponsor the victim in the foreign country or they can help sponsor the victims family here in the United States. Counselors will be on staff by phone to help with the mental anxiety that goes along with the loss of a family member. (Part three) This section brings news of lawbreaking immigration stories to the public eye. It is illegal under the fourth amendment for police, immigration officers, ICE, or customs and border protection officers to come in to peoples homes at 5 o'clock in the morning heavily armed without a warrant. This is a clear violation of law. Can you imagine if your home was entered by armed men and one of your family members were kidnapped? This is exactly what happens to immigrants. Why you might ask? It is all about money in most cases. The local jails, politicians, police, and the corrupt Corrections Corporation of America make billions of dollars off of these bonds on the immigrants and through a process called fractional banking. ImmigrationPAL will go after these corrupt people. ImmigrationPAL and Yale Law school are ready to begin this process. There will be no illegal immigration on either side of the table. Families will not be split apart any longer. Crooks will no longer be able to pray on deportation victims or their families. Judges will be removed from office. Laws will be reversed so the innocent people are fairly treated. The crooked laws of 1996 will be stricken from the books. Ice, Homeland Security, and Customs and Border Protection will be trusted again as they do the right thing and protect our country. Terrorists will find it impossible to come here. God will be honored in

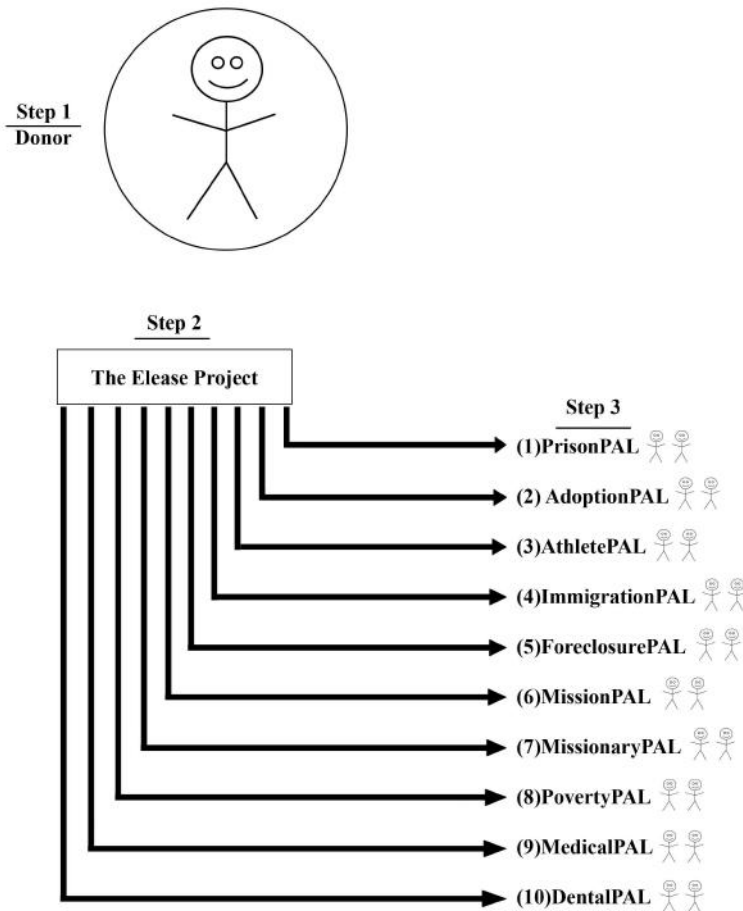

The ten PALS (section) of The Elease Project are unique in structure. When Keith Hatchett researched the wealthy people of the United States and how they fund charities, he found an unusual problem in that the donor had to say no to many charities each year and yes to only one or two. This is a problem and an uncomfortable problem as most people hate to say no to charities.

The Elease Project was designed to help with this problem. Now a potential donor can donate to The Elease Project and their money is equally divided into ten categories. The following diagram/flowchart demonstrates the process and lists the ten individual categories.

ImmigrationPAL Beta Test

Our beta test for ImmigrationPAL will begin in West Palm Beach, Florida. This immigration case is of significance as a married couple that was married for two years and two months, were split up by the United States government. This is 100% illegal. Homeland security and the West Palm Beach sheriffs office came to the home on April 2, 2008 and forced entry into a home in a gated community. The white male is a successful person in business. He is married to his Hispanic wife for 11 years. His wife is very light-skinned (Italian appearance), beautiful, Christian, and has a college degree. It is a clear violation of the fourth amendment for them to enter the immigrant's home **wrongfully without a warrant**. The husband demanded a warrant and they refused to show him one. He also demanded an arrest warrant and was not shown one. They handcuffed his wife and put her in a private prison in Pompano Beach, Florida. This is not a jail or federal prison. It is run by an illegal private corporation. It is unlawful to take a wife under the law from the husband as the wife is legal property of the husband.

ImmigrationPAL will work with Yale Law School and sue the Director of Homeland Security, Homeland Security itself, ICE, and Customs Border Protection. This is a landmark case that will be headline news in two months. The couple are Christians and have remained together despite the wrongful deportation and the nine year separation. In addition, the clients wife hired an attorney that never showed up for court. She has been suspended now twice for this wrongful activity. ImmigrationPAL will sue her on behalf of the client and her family for malpractice and the government for violation of the fourth amendment. It is unlawful to take a spouse from a spouse, **as under the law they are one**. ImmigrationPAL will be well funded to not only help this family but many more. A website is being created to make this story public that will create outrage and peaceful protests will be staged to demand the return of the wife. ImmigrationPAL is a God Fearing Bible based protection program for individuals and families. With God for us, who can be against us? There may be some against us and through ImmigrationPAL, those people will surely be defeated. We thank God in advance for helping us win this fight to defeat immigration and all the racism that goes along with it.
