Section 1

Introduction to MedicalPAL

Pediatric Innovation Education Center

MedicalPal is one of the 10 important entities of the Elease Project.

(Part 1)

The MedicalPal ministry addresses a huge problem in America today. Medical insurance is often very expensive or carries high out of pocket expenses that are not reimbursed by insurance. Founder Keith Hatchett created a unique system that lowers the cost of health insurance by 50% and increases the benefits to 100%.

The plan is based on combining two different insurance policies that eliminate a patient medical bills with a unique structure and strategy. Many people have thousands of dollars of unreimbursed out of pocket expenses that their insurance company does not cover.

To date, 1,200 people are insured under this plan and more than 180 million people between the ages of 18 and 64 can also benefit from this program. This health insurance program can be found at www.GoInsurancePal.com.

(Part 2)

Tax deductible donation.

With the Elase Project, someone has the ability to receive a tax deduction by donating to an individual to help with their out of pocket medical expenses. The donor specifies the person's name and needed information and receives a tax deductible receipt for their tax records.

MedicalPal administrators contact the individual who has outstanding medical bills and complete a HIPAA form to allow direct communication with the hospital, doctor's office and lab provider.

Upon completion of the documents, the payment gets wired directly to the medical providers on behalf of the patient, paying the bills and resolving the problem for the individual.

(Part 3)

Term Life with Living Benefits.

This special type of life insurance covers both death and life, instead of only death benefits. If the insured becomes stricken with any of the 17 major critical illnesses covered, the policy allows to accelerate the death benefit to receive up to 90% while they are still living. This added living benefit policy provides the opportunity for the individual to sign up for a high deductible health insurance plan, thus lowering the policy cost by 75%. By reallocating 25% of the savings towards a \$ 500,000 living benefits term life insurance, it provides them coverage for critical and chronic illness at any time the insured is unable to perform two of the six activities of daily living (feeding, bathing, dressing, incontinence, personal hygiene, transfer and walking functions). The policy also eliminates the need for long-term care and disability insurance and the benefits are paid out tax free.

(Part 4)

Faith based Community Ministry

A community finds common ground by being rooted in God's Love as the greatest Healer, especially in the midst of adversity and crises. Love alone casts out Fear and shifts our focus to spiritual healing. By building a strong Community of *Heart, Health and Hope* for one another, we strengthen our bonds through faith and trust in God. Through our collaboration of heart centered action, we can conquer the greatest obstacles in Life.

MedicalPal supports faith based Community Ministries nationwide through the vast network of local churches that provide community oriented help to those in need. By providing additional

support through the addition of an *e-Ministry* within the church, it can offer vital and reliable information and resources during a period of crisis and act as the nucleus GO TO place within the Community. The *e-Ministry* is vital for streamlining the logistics and distribution process to support those with the greatest needs on an ongoing basis and during a crisis situation.

What is an *e-Ministry* and how does it work?

A Heart-Centered Community Initiative led by Community Churches that enables our communities to come together in times of great need to serve those in isolation without the ability to access essential items and care for themselves. The local church will be the Community's GO TO place in emergency and crisis situations by providing the necessary streamlining and organization to respond to a crisis situation within their community.

The Elease Project raises awareness and seeks funding through grants, sponsorships and donations by continually expanding the network of churches to bring this added *e-Ministry Initiative* to existing churches and their respective communities across America. The *e-Ministry* supports self-reliance in crisis situations to organize quickly and to be better prepared to impact many lives through effective organization, distribution of essential items, food, medical supplies and other services for the elderly and those in need at a moment's notice.

For additional help with critical financial support of specific individuals or families within the Community, the Elease Project and its *PovertyPal* entity provides a simple way to donate directly to the individual for help with medical expenses, food and other needed supplies during the crisis. The Mission of a True Community:

The "Love thy Neighbor" Initiative is led by a coalition of community members, businesses and organizations, facilitated by Quantum Living Solutions. The goal is to organize and educate churches on how to operate their own *e-Ministry* as an added community outreach program facilitated through an online infrastructure and educational curriculum to help plan for an emergency or crisis.

The coalition brings this Community-based Initiative to the forefront by empowering other communities nationwide to be better prepared and self-reliant in case of crises whenever government aid is not readily available.

Staying connected via a private online support network within the community will be an important aspect to help communicate vital information and organize the distribution of essential supplies and services at a moment's notice. Reliable and trusted sources of supplies and services will inform, educate and empower the community members to be engaged and play a vital role in the overall health and wellbeing of their community.

The Church's *e-Ministry* members can be trained in the logistics of transportation and distribution of the needed resources by their *Emergency Response Task Force*, comprised of the church members and their affiliated community businesses and organizations. The Community can swiftly organize the sharing of resources, delivery of medical supplies, food distribution and implementation of various efforts that become vital in a crisis or emergency response.

Through the efforts of the Elease Project and a task team, a nationwide Campaign is underway to share this important initiative with as many churches as possible to build a strong coalition during the current COVID-19 crisis and beyond.

(Part 5)

COVID-19 online screening tool:

The Elease Project through MedicalPal's entity supports an important initiative led by two scientists who teach Bioinformatics at Johns Hopkins University and are among the top experts in the world in DNA & RNA analytics fields. They developed an online screening tool to help save lives by identifying the symptoms for higher risk individuals to get tested sooner. This online tool is an excellent example of how scientific research can be quickly adopted to guide us on how to better prioritize testing decisions.

The online screening tool is their initial contribution to the world's crisis and will be expanded further with reliable, scientifically backed medical information and education to support individuals in their efforts to stay healthy. For the free online screening test, go to www.screencovid.org

The Team

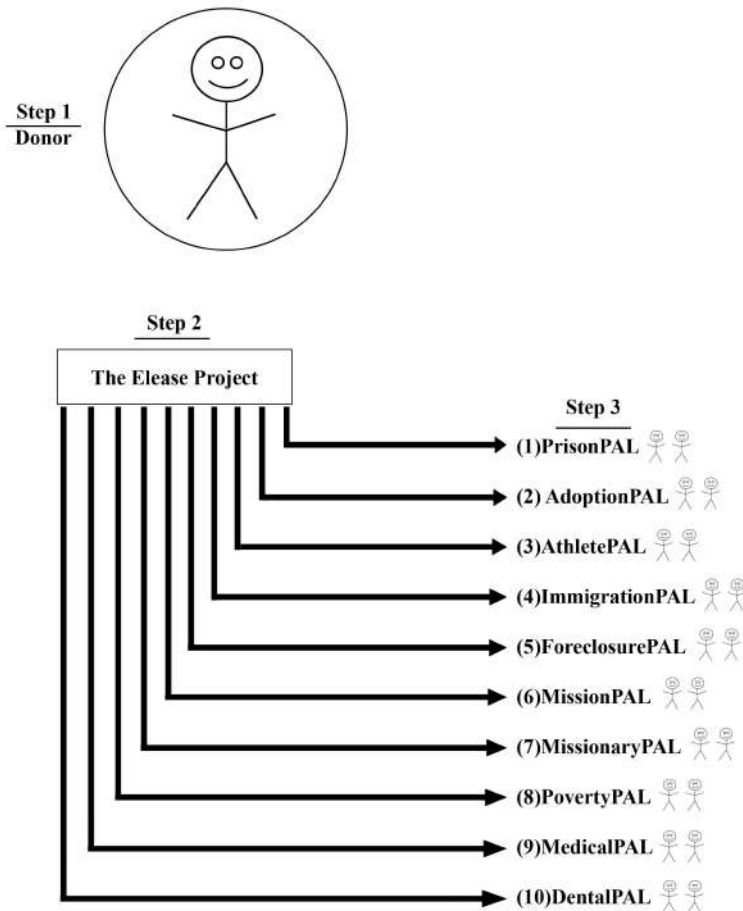

The Ten PALS Structure

The ten PALS (section) of The Elease Project are unique in structure. When Keith Hatchett researched the wealthy people of the United States and how they fund charities, he found an unusual problem in that the donor had to say no to many charities each year and yes to only one or two. This is a problem and an uncomfortable problem as most people hate to say no to charities.

The Elease Project was designed to help with this problem. Now a potential donor can donate to The Elease Project and their money is equally divided into ten categories. The following diagram/flowchart demonstrates the process and lists the ten individual categories.

Section 3

MedicalPAL Beta Test

MedicalPal fills a critical gap for individuals and families who are unable to pay for their out of pocket medical expenses due to Covid-19 and to those who have no income to purchase food and necessary supplies because of losing their employment. MedicalPal will start its first BETA tests providing assistance in the cities of Daytona Beach Florida, Nashville Tennessee and the Metropolitan area of Washington DC, Maryland and Virginia.

Donations will be distributed evenly between MedicalPal for non-covered medical expenses and PovertyPal for providing food and necessary supplies to those who lost their income. For a donation specific to an individual, family, church or organization, specify the name and needed information so the funds can be directly paid to the designated parties. A tax deductible receipt will be emailed upon completion of the online donation.

The local, state and federal government is doing all it can to provide the critical medical supplies and assistance with financial aid. MedicalPal and PovertyPal are the answer to get to Communities quickly and provide critical support that the other agencies are not equipped to fulfill due the overwhelming need. Together we can make a life changing difference that would otherwise not be possible.
